### Rules with an effective date of July 1, 2017 are as follows:

\* **Amendment to 15.2.1.7 NMAC**

The following changes were made:

1. In Subsection O (*Definitions beginning with the letter "o"*) a definition for an "Official sample" was inserted.
2. In Subsection P (*Definitions beginning with the letter "p"*) the definition for "Positive test" and "Prohibited substance" were amended.

\* **Amendment to 15.2.1.9 NMAC**

The following changes were made:

1. In Subsection C (*Proceedings Before the Commission*) Paragraph (13)(a) & (c) were amended.

\* **Amendment to 15.2.3.8 NMAC**

The following changes were made:

1. In Subsection C (*Racing Secretary*) Paragraph (4) was amended.

\* **Amendment to 15.2.6.9 NMAC**

1. In 15.2.6.9 NMAC (*Medications and Prohibited Substances*) amendments were made to update this section with the current ARCI Uniform Classification Guidelines for Foreign Substances and Recommended Penalties and Model Rule and also the Controlled Therapeutic Medication Schedule for Horses.
2. In Subsection B (*Penalties*), Paragraph (2), was amended to reference Subsection N instead of Subsection P.
3. In Subsection C (*Medication restrictions*) numerous amendments were made.
4. In Subsection G (*Androgenic-anabolic steroids*) an amendment was made to reference an “official sample”.
5. In Subsection J (*Out of competition testing*) numerous amendments were made.

\* **Amendment to 15.2.6.10 NMAC**

1. Subsection A (*Reporting to the test barn*) was amended to reflect an official sample.
2. Subsection D (*Storage and shipment of split samples*) was amended to eliminate the phrase “chain of custody form”.

\* **Amendment to 16.47.1.8 NMAC**

1. Subsection A (*Licenses Required*) Paragraph (2) was amended to show an increase in all fees and Paragraph (3) was amended to reflect that anyone under the age of 18 would be exempt from the requirement to submit fingerprint cards.
2. Subsection N (*Changes in application information*) was amended to reflect the fee of replacement badges.

\* **Amendment to 16.47.1.15 NMAC**

1. Inserted new subsection entitled “*Pony Person and Exercise Rider Eligibility*”, all subsequent subsections were re-lettered.
