RE: 2018-SUN-30 - Ruling Final Outcome

Jockey, BRANDON CHANCE BOULANGER, was summarily suspended on January 12, 2018, and waived his rights to a formal disciplinary hearing before the Board of Stewards on January 21, 2018. Jockey BRANDON CHANCE BOULANGER tested positive for marijuana metabolites during a drug screening on January 12, 2018.

The Board of Stewards hereby suspend all NMRC licenses belonging to **BRANDON CHANCE BOULANGER** for 60 days (retroactive from the summary suspension issued on January 12, 2018) January 12, 2018, through March 13, 2018, inclusive. 30 days will be deferred upon immediate enrollment in Chaplain Donald Stover's "Turning Point Program" (16.47.1.18(C)NMAC). After 30 days has been served BRANDON CHANCE BOULANGER must submit a negative sample and is given probationary status. Furthermore BRANDON CHANCE BOULANGER may be tested at the request of the stewards at any time. Failure to attend "The Turning Point Program" will result BRANDON CHANCE BOULANGER's immediate suspension to serve the remainder of the 60 days.

Per 15.2.1.9 (C)(21)(a-b) NMAC, While under suspension, BRANDON CHANCE BOULANGER is excluded from all areas of the grounds under the jurisdiction of the NMRC.

RE: 2018-SUN-50 - Modified Ruling 15.2.3.8(B)(1)(e) Stewards Authority The stewards shall have the authority to amend, revoke, rescind or modify any ruling that they issued in error in accordance with the laws of this state and these rules. Five thousand dollar penalty was inadvertently omitted in original ruling.

Owner Jorge Carrillo was duly notified and responded telephonically for a hearing before the Board of Stewards on January 20, 2018. The hearing was in regard to an affidavit from UC/Davis (official testing laboratory for the NMSRC) for a confirmed positive for drug "Caffeine" (drug class 2, penalty B) detected in horse "Kick Some Dash" (Test Sample NM30204), who finished 1st place in the 7th race on November 25, 2017, at Zia Park Racetrack in Hobbs, NM.

The original lab report indicated a finding of Caffeine at a level of 164 ng/ml in the blood, which exceeds the regulatory threshold limit for Caffeine of 100 ng/ml in the blood (15.2.6.9 (L)(3)(C)). Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to and declined by Michael Megariz III.

Michael Megariz III, the trainer of record for horse "Kick Some Dash", was duly notified and appeared for this hearing. This is Michael Megariz III's SECOND Penalty B medication violation in a lifetime.

For Jorge Carrillo's FOURTH Penalty B medication violation, issued in accordance with 15.2.6.9 (B)(2) Penalty Recommendations, the Board of Stewards hereby assess a penalty as follows.

- 1. A five thousand dollar (\$5,000) fine to be paid on or before January 23, 2018, in accordance with 15.2.3.8 (B)(3)(1) NMAC. Failure to pay fine in prescribed time may result in an immediate suspension.
- 2. The horse "Kick Some Dash", is hereby disqualified from FIRST PLACE and ordered unplaced from the 7th race on February November 25, 2017, at Zia Park Racetrack, for all but pari-mutuel wagering. The purse redistribution is as follows.
  - 1) Pernambuco
  - 2) June Bug Junior
  - 3) Wood Be a Bullet
  - 4) If Ur Cute Im Quick
  - 5) Penny Snipin
  - 6) Passtheflower
  - 7) Crème Dela Cartel
  - 8) Eunaway Siesta
  - 9) Magic Lil Jesse
