Trainer Jesus Rondan Jr. was duly notified and responded telephonically before the Board of Stewards on **January 2, 2018**, for failing to take possession of claimed horse "**MAD MAX CARTEL**" after the running of the 5th race on December 9, 2017, at Zia Park Racetrack.

The Board of Stewards hereby assess **Jesus Rondan Jr.** a fine in the amount **of two hundred dollars, (\$200.00)**. The fine is to be paid on or before **February 2, 2018**, in accordance with 15.2.3.8 (B)(3) (1) NMAC. Failure to pay the fine within the time prescribed may result in immediate suspension

The successful claimant or their representative shall also accompany the horse to the test barn.
