Trainer: Osman Iturralde was duly notified, appeared and waived his right to a hearing, before the Board of Stewards on August 19, 2018. The hearing was in regard to a certificate of analysis from Industrial Laboratories (official testing laboratory for the NMRC) for a confirmed positive for the (class 4 penalty C Major) drug "Dexamethasone" in horse "Discrete" (Test Sample #: E276575) who finished in First place in the 7th race on July 20, 2018, at the Downs at Albuquerque.

The certificate of analysis detected "Dexamethasone" at a level of 30.2 pg/ml in the blood, which exceeds the authorized limit of 5 pg/ml. (15.2.6.9) NMAC attachment #4). Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to and declined by Osman Iturralde.

Ramon Sevastian Chavarria, the owner of record for the horse "Discrete", was duly notified. In accordance with 15.2.6.9 (B)(4) Penalty Recommendations, This is Osman Iturralde's Second Class 4C-Major medication violation in a 365day period.

For Osman Iturralde's Second Class 4C-Major medication violation in a 365-day period, the Board of Stewards hereby assess a penalty issued in accordance with 15.2.6.9 (B)(4) Penalty Recommendations, as follows:

- 1. A (\$1500.00) One Thousand Five Hundred dollar fine to paid on or before September 19, 2018. In accordance with 15.2.3.8 (B)(4)(1) NNRC, failure to pay the fine in the prescribed time will result in an immediate suspension.
- 2. A 15 day suspension of all NMRC licenses starting August 20, 2018, through September 3, 2018, inclusive.
- 3. During said time of applicable suspension Osman Iturralde is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC, in accordance with 15.2.1.9 (C)(21). Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Osman Iturralde are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (C)(21)(c). All transfers and sales of horses trained by, owned by, or in the care and custody of Osman Iturralde must be done in accordance with 15.2.6.9A(12)(a)(b) NMAC.

Jockey , Armando Alvidrez having been summoned and having appeared telephonically before the Board of Stewards on August 19, 2018 for careless riding during the running of the 8th race on August 18, 2018 at The Downs at Albuquerque Racetrack while aboard "#10 Ls Power" which resulted in his mount being disqualified from 1st place to 2nd place behind the horse interfered with.

Licensee is found in violation of:

15.2.5.13(E)(2)(a) NMAC: Post to Finish Which states in pertinet part that "A jockey shall not ride carelessly or willfully so as to permit his/her mount to interfere with, impede or intimidate any other horse in the race."

15.2.5.13(E)(3)(d) NMAC: Post to Finish (d) In a straightaway race, every horse must maintain position as nearly as possible in the lane in which it starts. If a horse is ridden, drifts or swerves out of its lane in such a manner that it interferes with, impedes or intimidates another horse, it is a foul and may result in the disqualification of the offending horse.

For this violation, the Board of Stewards assessed Armando Alvidrez a suspension of 7 calendar days (August 27, 2018, through September 2, 2018). The terms of this suspension shall not prohibit participation in designated races.

Trainer: Benito Guillen-Vega, having been duly notified and having waived his right to a hearing before the Board Of Stewards on August 19, 2018, regarding a lab report from Industrial Laboratories (the official testing laboratory for the NMSRC), for a confirmed positive for the therapeutic drug, Phenylbutazone (class 4 penalty category C drug) found in test sample E276627 taken from the horse Harlan County following the 5th race, on July 22, 2018 at the Downs at Albuquerque

The original lab report indicated a finding of Phenylbutazone at 2.48 micrograms per milliliter in the blood, which exceeds the allowable limit of 2.0 micrograms per milliliter in the blood. Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to and declined by Benito Guillen-

Deni Rodarte-Puente is the owner of record for horse "Harlan County"

In accordance with 15.2.6.9 (C)(2)(b) NMAC, this is Benito Guillen-Vega's FIRST Class 4C-minor violation.

For this FIRST Class 4C-Minor medication violation issued in accordance with 15.2.6.9 (C)(2)(b) NMAC, the Board of Stewards assessed Benito Guillen-Vega a penalty as follows:

A positive test for a prohibited drug or medication or other prohibited substance or the presence of permitted medication in excess of maximum allowable levels as reported by the commission approved laboratory is prima facie evidence of a violation of this rule. The Trainer is absolutely responsible regardless of the acts of third party."

Groom, Jose De La Cruz, is hereby summarily suspended (effective immediately, August 24, 2018) after having appeared before the Board of Stewards on August 24, 2018, for testing positive for Meth amphetamines (a prohibited substance) during a routine drug screening and drug paraphernalia and drugs found in the tack room.

During said time of applicable suspension Jose De La Cruz is hereby excluded from all areas of the grounds under the jurisdiction of the NMSRC, per 15.2.1.9 (C)(21), pending the outcome of his hearing on September 2, 2018, at 10:30 am in the board of Stewards Office at The Downs at Albuquerque in accordance with 15.2.1.9 (B)(3)(b).

With regard to other controlled substances, presence of the drug in any quantity measured by the testing instrument establishes the presence of the drug for purposes of this paragraph. Licensees in safety sensitive positions, jockeys, starters, assistant starters, exercise riders, pony persons, ambulance personnel, and outriders are in violation of this rule if they have any measurable level of alcohol.

16.47.1.8 (L)(1)(i) - Which states in pertinent part "The Commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures if the applicant is a person whose conduct or reputation may reflect on the honesty, and integrity of horse racing" 16.47.1.17 (A)(1) TESTING PROCEDURES At its discretion, the commission may conduct random or episodic random drug testing, as well as testing based on reasonable suspicion, in order to ensure safety on the racetrack.
