The Board of Stewards hereby assesses a penalty as follows.

1. The horse "Colorful Colorado", is hereby disqualified from first place and ordered unplaced from the 8th race on October 14, 2019, at Zia Park Racetrack, for all but pari-mutuel wagering. The purse redistribution is as follows.
