Upon receipt of ruling **RETA2629** (issued on **July 31, 2017**, by The Texas Racing Commission summarily suspending Trainer Judd Kearl), the Board of Stewards at Ruidoso Downs hereby suspend Trainer Judd Kearl, pursuant to 15.2.1.9(B)(8)(c) Effect of Rulings and 16.47.1.8 (L)(1) (h) Reciprocity, pending the outcome of a disciplinary hearing by the Texas Racing Commission. Any and all licenses issued to Mr. Kearl by the New Mexico Racing Commission will be affected by this ruling.

During his suspension, Judd Kearl is hereby excluded from all areas of the grounds under the jurisdiction of the NMSRC 15.2.1.9 (C)(21)(a). In addition all horses owned, trained by, or in the care and custody of Judd Kearl are ineligible to be entered or start in this jurisdiction, per 15.2.1.9 (C)(21)(c), pending bona fide sales and/or transfers with the approval by the Board of Stewards.

Trainer Toby Keeton, having been duly notified and having appeared before the Board of Stewards on August 3, 2017, concerning a hearing that was continued at the request of Mr. Keeton from July 21, 2017. The hearing was in regard to Toby Keeton's failure to comply with the New Mexico Racing Commission Investigator and Commission Authorized Veterinarian, Dr. Chastain, for out of competition testing on June 22, 2017 at Ruidoso Downs.

MIDIGATING CICUMSTANCES: No specific horse was selected for out of competition testing AGGRIVATING CIRCUMSTANCES: Mr. Keeton was disrespectful to racing officials and failed to comply with their instructions.

After considering the AGGRIVATING CIRCUMSTANCES and MIDIGATING CICUMSTANCES, the Board of Stewards hereby access Toby Keeton:

- 1. A penalty of a 30 day suspension of all NMRC licenses starting August 13, 2017, through September 12, 2017, inclusive.
- 2. A fine in the amount of five hundred dollars (\$500.00). The fine is to be paid on or before September 3, 2017, in accordance with 15.2.3.8(B)(3)(1). Failure to pay the fine within the time prescribed may result in immediate suspension.

During said time of applicable suspension Toby Keeton is hereby excluded from all areas of the grounds under the jurisdiction of the NMSRC, in accordance with 15.2.1.9 (C)(21)(a-b). Additionally, effective upon applicable suspension dates, all horses owned or trained, or under the care of Toby Keeton are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (C)(21)(c).
