Anthony Medina tested positive for cocaine during a drug screening on August 31, 2017. Per 15.2.1.9 (C)(21)(a-b) NMAC, Anthony Medina is hereby excluded from all areas of the grounds under the jurisdiction of the NMSRC.

Licensees in safety sensitive positions, jockeys, starters, assistant starters, exercise riders, pony persons, ambulance personnel, and outriders are in violation of this rule if they have any measurable level of alcohol.
