		Today the horse racing industry in New Mexico is perched on a precarious precipice and with a misstep by not doing the right thing, the consequences could be catastrophic to the industry. All stake holders in the industry have been looking for certainty since the pandemic began. Without certainty, it is difficult for these people to plan their next steps. Pursuant to conversations on August 6, Penn National will continue to wait for confirmation from the Governor's office whether or not racetrack casinos will be allowed to reopen prior to making a final decision to continue the upcoming race meet. If confirmation that casinos will be allowed to open, it will take Zia Park 5 weeks preparation and open on week 6. Given this timeline should the confirmation about reopening casino racetracks on September 30th or later, Penn National does not feel it is advantageous to run the race meet in 2020. As of today, Zia Park is planning to open as scheduled awaiting confirmation from the Governor's office. Mr. Erhard noted that Zia Park is situated similar to Ruidoso Downs and does not feel that they should be allowed to wait to decide whether to open the 2020 race meet based on the Governor's decision as Ruidoso Downs and DAA did not wait for any news from the Governor. Mr. True did not understand this discussion. Mr. Trejo clarified by saying the gaming statutes states that the commission must first approve any variance of race days per week or number of races per day. The Association has to submit a written approval from the State Racing Commission to the Gaming Board. That Association needs to get with us, in this scenario, preferably August 7 and August 9, the day of entries for August 14 and 16, respectively, and give the Commission a heads up that they are going to deviate from the requirement to run x number of races or x number or race days per week. In this case the Commission was not notified.
