| | | Specifically, the NMHA have reached an agreement with the DAA to support a race meet from August 8, 2020 through September 20, 2020, with one final race day on October 24, 2020 for a total of 27 race days. In addition, at this time, the NMHA will support the Downs at Albuquerque's proposed \$100 per head starter fee. However, should the current restrictions on track casinos and fan-based attendance change over the course of this meet, the NMHA request that the DAA reconsider their request for this starter fee. NMHA would also request the issue of a starter fee be considered as a one-time, non-essential issue, that is a direct result caused by the Covid-19 Pandemic and not be cited as a precedent for future discussions. | |
| | | Finally, there is a request to bring the Purse Tax Agreement of May 11, 2020 and approved by the NMRC on May 28, 2020 before the Commission at this meeting. Chairwoman Bourguet believes that this Purse Tax Agreement is part of the agenda as the 2020 purse money and the purse tax agreement is the horsemen's purse money and needs to be looked at. AAG, Tenorio respectfully disagrees and states that the letter written by Jeff True of Ruidoso Downs, referred to by Mr. Erhard in his report, while it does discuss purse money, that purse money is directly connected to the purse tax agreement that was signed back in May, the letter written by Mr. True that Mr. Erhard is referring to specifically requested that the agreement be reconsidered by this Commission.
