The original lab report indicated a finding of **Dexamethasone at 172 pg/ml in the blood**, the allowable limit for Dexamethasone is 5 pg/ml in the blood (15.2.6.9 Attachment 2 Page 3). Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to and declined by John Cooper.

John Cooper, the trainer of record for horse "He Be Flashy", was duly notified and waived his rights to a formal hearing. In accordance with 15.2.6.9(B)(4) PENALTY RECOMMENDATIONS, this is John Cooper's FIRST Class 4C medication violation in a 365- day period.

Jockey <u>Daniel Antonio Torres</u>, having been summoned <u>and having been represented by jockey JC Rivas</u> before the Board of Stewards <u>January 13, 2018</u> for careless riding during the running of the <u>6th race on January 12, 2018</u>, at <u>Sunland Park Racetrack</u>, while <u>aboard "BIG DADDY RF"</u>, which resulted in his mount being disqualified from 4th place to 9th place. (Bore in sharply, causing #4 to clip heels.)

For this violation, the Board of Stewards assessed <u>Daniel Antonio Torres</u>, a suspension of <u>7</u> <u>calendar days (January 21, 2018, through January 27, 2018)</u>. <u>Daniel Antonio Torres</u> is allowed to ride designated races.
