Ramon Alvarez Jr. waived his rights to a 10 day notice of hearing for a disciplinary hearing. The hearing was in regard to Ramon Alvarez Jr. working as a groom, a capacity for which he was not licensed, on February 24, 2018, at Sunland Park Racetrack.

The Board of Stewards hereby fines **Ramon Alvarez Jr**. in the amount of **two hundred dollars (\$200)**. The fine is to be paid on or before **April 3, 2018**, in accordance with 15.2.3.8(B)(3)(l) NMAC. Failure to pay this fine within the time prescribed may result in immediate suspension.

Trainer Ramon A. Alvarez was duly notified and appeared for a summary suspension hearing on February 27, 2018. Ramon A. Alvarez waived his rights to a 10 day notice of hearing for a disciplinary hearing. In concern to horse "Tarzan on Fire", Ramon A. Alvarez failed to conduct business in a proper manner on February 24, 2018, at Sunland Park Racetrack.

The Board of Stewards hereby fines Ramon A. Alvarez in the amount of five hundred dollars (\$500). The fine is to be paid on or before April 3, 2018, in accordance with 15.2.3.8(B)(3)(1) NMAC. Failure to pay this fine within the time prescribed may result in immediate suspension.
