A report has been received from the Industrial Laboratories Company, Wheat Ridge, Colorado, stating that blood sample 0002404 collected from "SPIT PRIZE CORONA" that Placed 1st in the 8th Race, on Sunday, April 15, 2018, did test positive for the drug Albuterol as reported in an affidavit from Industrial Laboratories signed by Timothy Krueger, Supervisor DTS.

On Saturday, April 28, 2018, the Board of Stewards at Remington Park determined that the public health, safety, and welfare is at risk because Albuterol is a prohibited substance with no acceptable threshold level for Quarter Horses and which can affect the performance of a horse and potentially affect the welfare of the betting public, other licensees and horses in his care...

Pursuant to OAC 325:70-1-20. Summary Suspension of Occupation Licensee, the Board of Stewards finds that the public health, safety, and welfare is at risk and requires emergency action. Therefore, Fernando Carrete, DOB: 06/03/1988, is hereby summarily suspended effective Saturday, April 28, 2018, and continuing pending a hearing and final determination.

During the term of his suspension, Mr. Carrete is denied access to the enclosures of all racetracks, including the public areas coming under the jurisdiction of the Oklahoma Horse Racing Commission.
