Owner/Trainer, Javier Montoya, having appeared before the Board of Stewards on December 6, 2016, following a summary suspension issued December 5, 2016 (2016-ZIA-153) for a hearing that was continued from December 5, 2016, for his involvement with needle found in the procession of owner Hilda Mojica (girlfriend). Ms. Mojica was found in procession of the needle while standing outside of receiving barn stall # 59, assigned to Javier Montoya.

On December 4, 2016, NMRC Investigator Wiseman witnessed the passing (by hand) of a needle from inside of receiving barn stall #59 (assigned to Javier Montoya for in-today horse "VMR REBEL" scheduled to run the 9th race at Zia Park on December 4, 2016) to owner, Hilda Mojica (girlfriend). NMRC Investigator Wiseman also witnessed that Javier Montoya was present inside the stall at the time of this incident.

For this violation the Board of Stewards issue the following penalty:

1. A <u>6 month</u> suspension of any/all New Mexico Racing Commission licenses, effective <u>December 5</u>, 2016, through June 6, 2017, inclusive

2. A (\$1,500) one thousand five dollar fine The fine is to paid on or before <u>January 10, 2017</u>, in accordance with 15.2.3.8(B)(3)(I) NMAC. Failure to pay the fine within the time prescribed may result in immediate suspension

Trainer Cody Reynolds having been duly notified and having appeared before the Board of Stewards on December 10, 2016, for a hearing that was continued from December 4, 2016, regarding a lab report from UC/Davis (official testing laboratory for the NMSRC), for a confirmed positive for the prohibited Class 3B drug "16-hydroxystanozolol" a metabolite of stanozolol detected in horse "Furiousprincess", test sample # 21276, who finished second place in the 11th race, on October 29, 2016 at Zia Park Racetrack in Hobbs, NM. Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to and declined by Cody Reynolds.

Rachael Reynolds, the owner of record for the horse "Furiousprincess", was duly notified and failed to appear for the hearing. Pursuant to rules 15.2.6.9 (L) and 15.2.1.9(B)(4)(d), this is Ms. Reynolds's FIRST Class 3B medication violation in a 365 day period.

For this FIRST Class 3B medication violation in a 365 day period issued in accordance with 15.2.6.9 (L) NMAC, the Board of Stewards assessed Cody Reynolds a penalty as follows.

- 1. A 30 day suspension of all NMRC licenses starting December 19, 2016, through January 18, 2017,
- 2. (\$750) seven hundred and fifty dollar fine to paid on or before January 10, 2017, in accordance with 15.2.1.9(B)(7)(f) NMAC and 15.2.3.8 (B)(3)(I) NMAC. Failure to pay fine in prescribed time may result in an immediate suspension.
