Jockey Alan Hernandez was summoned and appeared before the Board of Stewards on November 11, 2019, for careless riding during the running of the 8th race on November 10, 2019 at Zia Park racetrack while aboard "Famous Julia", which resulted in his mount being disqualified from 2nd place to 3rd place. (Bore out impeding the number 3 who had to take up costing him the opportunity at a better placing.)

The Board of Stewards hereby assess Alan Hernandez a suspension of 7 calendar days (November 18, 2019, through November 24, 2019, inclusive The term of this suspension shall not prohibit participation in designated race days.

Licensee is found in violation of and this ruling is written in accordance with:

15.2.5.13(E)(2)(a) Post to Finish A jockey shall not ride carelessly or willfully so as to permit his/her mount to interfere with, impede or intimidate any other horse in the race."

15.2.5.13(E)(3)(d) Post to Finish In a straightaway race, every horse must maintain position as nearly as possible in the lane in which it starts. If a horse is ridden, drifts or swerves out of its lane in such a manner that it interferes with, impedes or intimidates another horse, it is a foul and may result in the disqualification of the offending horse.

Jockey Raul Herrera was summoned and appeared before the Board of Stewards on November 11, 2019, for failure to make sufficient effort to control his mount "Addy Ann Angel Eyes" in the 8th race on November 10, 2019, at Zia Park racetrack, (Which resulted in his mount being disqualified from 1st place to 9th broke out impeding the #8 and taking the running lane of #9.)

The Board of Stewards hereby assess Raul Herrera a fine in the amount of two hundred dollars, (\$200.00). This fine is to be paid on or before December 12, 2019, in accordance with 15.2.3.8 (B)(3) (1) NMAC. Failure to pay the fine within the time prescribed shall result in immediate suspension.
