		the past and up until today, the NMHA has been taking 1%, approximately \$500,000-\$600,000 a year of purse money with no authority under the law to do so. The NMHA has been taking a \$5.00 Starter Fee (in 2019 equaled to about \$103,000) and a \$2.00 Political Action Committee Fee (totaling about \$41,000) from the purse money with no authority under the law to do so. Chairman Bregman confirmed with Executive Director Trejo and Counsel whether they have seen any regulation or Statute which permits the NMHA to take this money. Mr. Trejo confirmed that he is not aware of any language permitting the NMHA to take the moneys. Mr. Bustamante confirmed that he has looked through the laws and regulations for the NMRC and has not seen any authority allowing the NMHA to take such money. Chairman further pointed out that if the NMHA did not take this money it would provide an additional \$700,000 to the purses for the individual horsemen to compete for which is Purse Money. Chairman Bregeman went on to say that he cannot support the NMHA receiving this money when it should be going into the pockets of the individual horsemen in the form of purses when they win a race. He cannot and will not support the NMHA taking this money when it is not supported by law. Vice-Chair Sanchez agreed with Chairman Bregman and moved to stop this practice immediately.	passed unanimously by roll call vote.

		Assistant Attorney General Tenorio clarified that the question before NMRC is whether or not the NMHA has the authority to require payments of money as outlined by the Chairman. If it does not the motion would then be that the NMHA to discontinue the practice of requiring the NMHA's membership pay their fees with whatever purse money that comes available to them or that they win during the racing season. This motion was suggested because these are items that are specifically set out in the NMHA's Bylaws. Bylaws are to provide that the NMHA or anybody knows what their authority is and specifically in this case there is no statutory or regulatory authority either that Mr. Bustamante, Ms. Tenorio or Chairman Bregman has been able to find that allows the NMHA to deduct these percentages or amounts from purse money that is received from the horses. It goes specifically against statute, not only under the Horse Racing Act but also the Gaming & Control Act. Both of these specifically provide the Commission the authority to, not only regulate purses, but also create rules and regulations regarding that 20% net take which makes up the purses for horseracing in NM. Chairman Bregman clarified that the motion as AAG Tenorio outlined, is Prohibiting, as the regulatory authority for horseracing in New Mexico, from continuing to allow the NMHA from taking this money from purse money; meaning the
