RE: 2024-SRP-22 - Ruling Final Outcome

Trainer Lynlye Benn having been duly notified and having appeared via Teams before the Board of Stewards at Ruidoso Downs on Thursday June 6, 2024, for a disciplinary hearing regarding background investigation and falsification of his NMRC license application.

**After hearing testimony and examining evidence presented, the Board of Stewards hereby issue the following penalty:**

1. Trainer and all other licenses issued by the New Mexico Racing Commission to Mr. Benn are hereby revoked.
2. Mr. Benn must appear before the New Mexico Racing Commission prior to any future licensing consideration.

**Licensee is found to be in violation of NMAC:**

16.47.1.8 (L)(1)(d) GROUNDS FOR DISCIPLINARY MEASURES The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant has failed to disclose or falsely states any information required in the application.
