RE: 2024-SRP-22 - Ruling Final Outcome

Trainer Lynyle Benn having been duly notified and having appeared via Teams before the Board of Stewards at Ruidoso Downs on Thursday June 6, 2024, for a disciplinary hearing regarding background investigation and falsification of his NMRC license application.

After hearing testimony and examining evidence presented, the Board of Stewards hereby issue the following penalty:

- 1. Trainer and all other licenses issued by the New Mexico Racing Commission to Mr. Benn are hereby revoked.
- 2. Mr. Benn must appear before the New Mexico Racing Commission prior to any future licensing consideration.

Licensee is found to be in violation of NMAC:

16.47.1.8 (L)(1)(d) GROUNDS FOR DISCIPLINARY MEASURES The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant has failed to disclose or falsely states any information required in the application.
