Juarez having been properly noticed and having responded by phone before the Board of Stewards at Ruidoso Downs on June 15, 2024, and having waived his right to a 10 day **notice and formal hearing** for entering an ineligible horse "Santa Elena" (no gate ok) for the 4th race on June 14, 2024 at Ruidoso Downs which resulted in a scratch.

The Board of Stewards hereby issued the following penalty:

1. A fine of Two Hundred Fifty Dollars (\$250.00) which must be paid on or before June 29, 2024, in accordance with **NMAC 15.2.3.8 (B)(3)(e)(i)**. Failure to pay the fine within the prescribed time may result in immediate suspension. Pursuant to Rule **NMAC 15.2.1.9 A(7)(f)** all fines imposed by the stewards shall be paid to the commission within 14 days after the ruling is issued, unless otherwise ordered.
