RE: 2024-RUI-36 - Modified Ruling

Jockey, Raul Adriel Ortega-Armendariz, having been summoned and having appeared before the Ruidoso Board of Stewards, on July 19, 2024, for careless riding during the running of the 2nd race on July 14, 2024, at Ruidoso Downs Racetrack, while aboard # 5 "Midnight Promise" bore in sharply causing interference to inside horses.

For this violation, the Board of Stewards issued the following penalty:

A 7-calendar day suspension, beginning on July 26, 2024, through August 2, 2024.

Mr. Raul Adriel Ortega-Armendariz may ride designated races.

Licensee is found in violation of:

15.2.5.13(E)(2)(a) NMAC: Post to Finish Which states in pertinent part that "A jockey shall not ride carelessly or willfully so as to permit his/her mount to interfere with, impede or intimidate any other horse in the race."

15.2.5.13(E)(3)(a) NMAC: Which states in pertinent part that "When the way is clear in a race, a horse may be ridden to any part of the course, but if any horse swerves, or is ridden to either side, so as to interfere with, impede, or intimidate any other horse, it is a foul."

15.2.5.13 (E)(3)(b) The offending horse may be disqualified, if in the opinion of the stewards, the foul altered the finish of the race, regardless of whether the foul was accidental, willful or the result of careless riding.

15.2.5.13(E)(3)(c) NMAC: Post to Finish Which states in pertinent part that "If the Stewards determine the foul was intentional, or due to careless riding, they may fine or suspend the guilty iockev."
