Ruling:

Trainer Gabriel Acosta having been properly summoned and having appeared before the Downs at Albuquerque Board of Stewards on September 21, 2024, and having waived his 10-day notice and formal disciplinary hearing for failure to have the correct horse "Jm Ferarri Lane" in the paddock for the 1st race on September 20, 2024, at the Downs at Albuquerque necessitating a late scratch and pari-mutuel wagering refunds.

**The Board of Stewards hereby assess the following penalty.:**

A fine of Five Hundred Dollars (\$500.00) which must be paid on or before October 6, 2024. Failure to pay the fine within the prescribed time may result in immediate suspension. Pursuant to Rule 15.2.1.9: A(7)(f) All fines imposed by the stewards shall be paid to the commission within 14 days after the ruling is issued, unless otherwise ordered.

Ruling:

Trainer Julian Honesto having been duly notified and having appeared before the Downs of Albuquerque Board of Stewards on September 22, 2024, waived his right to a 10-day notice and formal hearing for failure to have a flipping halter on his entry "Flashin the Ivory" for the 7th race on September 21, 2024, necessitating a late scratch and pari-mutuel refunds at the Downs at Albuquerque.

**The Board of Stewards hereby issue the following penalty:**

1. A fine of Five Hundred Dollars (\$500.00) which must be paid on or before October 6, 2024, in accordance with NMAC 15.2.3.8 (B)(3)(e)(i). Failure to pay the fine within the prescribed time may result in immediate suspension. Pursuant to Rule NMAC 15.2.1.9 A(7)(f) all fines imposed by the stewards shall be paid to the commission within 14 days after the ruling is issued, unless otherwise ordered.

**Licensee is found to be in violation of NMAC:**

15.2.5.8 (B)(6) Procedure for Entries No alteration may be made in any entry after the closing of entries, but an error may be corrected with permission of the stewards.


