Jockey Jose Ruiz having been duly notified and having appeared before the DAA Board of Stewards on September 26, 2024, for excessive use of whip, while aboard #5 "Moon Candy" in the 1st Race September 25, 2024, at The Downs at Albuquerque.

#### For this violation, the Board of Stewards issued the following:

Jose Ruiz (1st offense) a fine in the amount of Five Hundred Dollars. (\$500.00). This fine is to be paid on or before October 10, 2024, in accordance with NMAC 15.2.1.9 (A)(7)(f). Failure to pay the fine in the prescribed time shall result in an immediate suspension.

#### Licensee is found to be in violation of NMAC:

15.2.5.13(E)(6)(A) Use of riding crops. Although the use of a riding crop is not required, any jockey who uses a riding crop during a race shall do so only in a manner consistent with exerting his or her best efforts to win.

15.2.5.13(E)(6)(e) Use of riding crops. Indiscriminate use of the whip is prohibited including whipping a horse: on the head, flanks or on any other part of its body other than the shoulders or hind quarters except when necessary to control a horse; during the post parade or after the finish of the race except when necessary to control the horse; excessively or brutally causing welts or breaks in the skin; when the horse is clearly out of the race or has obtained its maximum placing; persistently even though the horse is showing no response under the riding crop; or striking another rider or horse.
