RE: 2024-ZIA-12 - Modified Penalty

Trainer, Zackary Stinebaugh having been properly summoned and having waived his right to a 10-day notice and formal disciplinary hearing over the phone on November 10, 2024 for entering an ineligible horse "Kung Fu King" in the 10th race on November 10, 2024 which necessitated a late scratch at Zia Park,

(Texas Claim Rule Sec. 313.308. Restrictions on Subsequent Use (a) A horse claimed in a claiming race in Texas

1. May not be sold or transferred in whole or part, by any method other than a claiming race during the 30-day period after the initial claim;
2. **And is ineligible to start in a race meeting other than the one at which it was claimed until the end of the meeting at which the horse was claimed, except in a stakes race after verification by the board of stewards.**

For this violation, the Board of Stewards assess the following penalty:

1. A fine in the amount of Two Hundred Fifty Dollars (\$250.00). The fine is to be paid on or before November 25, 2024. Failure to pay the fine within the prescribed time shall result in an immediate suspension. Pursuant to Rule 15.2.1.9 A(7)(f) NMAC. All fines imposed by the stewards may be paid to the commission within 14 days after the ruling is issued, unless otherwise noted, in accordance with Rule 15.2.3.8 (B)(3)(e)(i),

Licensee is found to be in violation of:

15.2.5.8 (B)(7) Procedure for Entering: The person making an entry shall clearly designate the horse so entered.

16.47.1.10 (C)(17) (18) Trainer Responsibility: The trainer is responsible for representing an owner in making entries and scratches and in all other matters pertaining to racing; horses entered as to eligibility and weight or other allowances claimed.
