Owner Larena A Benn appeared via Microsoft Teams for a Summary Suspension Hearing on November 3, 2024, @ 10:00 a.m. with the Board of Stewards at Zia Park, 3901 W Millen Drive, Hobbs NM 88240 per 15.2.1.9 (B)(3)(b) Summary Suspension. The summary suspension was regarding her husband (Lynyel J Benn) being suspended for falsification of his license application. Furthermore, the board of stewards determines that Larena A Benn shall remain summarily suspended pending the outcome of her husbands (Lynyel J Benn) case or show legal documentation of separation or divorce.

In accordance with 15.2.1.9 (C)(21), Owner Larena A Benn is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Larena A Benn are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (C)(21)(c). All transfers and sales of horses trained, owned, or in the care and custody of Larena A Benn must be done in accordance 15.2.1.9(B)(8)(b) DUE PROCESS AND DISCIPLINARY ACTION.

In accordance with 15.2,6.9 (A)(12)(a)(b)(c),

- (a) first degree of affinity shall mean the licensee's spouse or spouse's mother, father, brother, sister, son or daughter.
- (b) first degree of consanguinity shall mean the licensee's mother, father, brother, sister, son or daughter.
- (c) No entry in any race shall be accepted for a horse owned wholly or in part by, or trained by, a person whose husband or wife is under license suspension at time of such entry; except that, if the license of a jockey has been suspended for a routine riding offense, the stewards may waive this rule. Licensee is found in violation of and this ruling is written in accordance with:
- 15.2.1.9(B)(3)(a) Proceedings Before The Stewards: Summary Suspension If the Stewards determine that a licensee's action constitute an immediate danger to the public health, safety, or welfare, the Stewards may summarily suspend the licensee pending a hearing.

Jockey Ali Rivera having his agent appeared telephonically before Zia Park Board of Stewards on November 2, 2024, for failure to honor or and be excused from his riding engagement for the 1st race on Saturday November 29, 2024, at ZIA Park Racetrack.

For this violation, the Board of Stewards assess jockey Ali Rivera a fine in the amount of Two Hundred and Fifty dollars, \$250.00. The fine is to be paid on or before November 16, 2024, in accordance with 15.2.3.8 (B) (3) (1). Failure to pay the fine within the time prescribed shall result in immediate suspension.

Licensee is found to be in violation of:

Trainer Ramon Mendoza having been duly notified appeared before The ZIA Park Board of Stewards on November 3, 2023, and waived his right to a formal hearing, regarding a lab report from Industrial Laboratories (The official testing laboratory for the NMRC), for a confirmed positive for the drug, Flunixin (class 4 C penalty drug) found in test sample E537834 taken from the 2nd place finisher "Razor Sharp" following the 5th race, at NMSF/DAA Racetrack on September 27, 2024.

The original lab report indicated a finding of Flunixin at 17.9 ug/ml +/-0.04 ug/ml in the blood, the allowable limit for Flunixin is 5 ng/ml in the blood for a 4-C violation (15.2.6.9 Attachment 2).

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the trainer, and declined by trainer.

Ramon Mendoza is the Trainer of record for horse "Razor Sharp" at the time of the violation.

This is Ramon Mendoza's first 4C-Major medication violation, in a 365-day period, issued in accordance with 15.2.6.9 (B)(4). The Board of Stewards assessed a penalty as follows:

Aggravating circumstances:

1. The allowable limit for Flunixin is 5 ng/ml, the horse "Razor Sharp" tested positive at a level of 17.9 ng/m Threshold of 5ng/ml.

Mitigating circumstances:

This is trainer Ramon Mendoza's first violation of this classification in 365 days.

The Board of Stewards hereby assess the following penalty.:

- 1) A fine of One Thousand Dollars (\$1000.00) which must be paid on or before November 18, 2024. Failure to pay the fine within the prescribed time may result in immediate suspension. Pursuant to Rule 15.2.1.9: A(7)(f) All fines imposed by the stewards shall be paid to the commission within 14 days after the ruling is issued, unless otherwise ordered.
- 2) Ramon Mendoza has accumulated "0" points prior to this ruling and "0.5" points in connection with this ruling for a current total of "0.5" under the multiple medication violation point system.

Split Sample rights were afforded to trainer Roberto Fournier and the owner, Juan Poblano. And was declined.
