RE: 2024-ZIA-33 - Modified Ruling

Jockey, Jacob Enriquez having been summoned and having appeared before the Zia Park Board of Stewards, on November 24, 2024, for careless riding during the running of the 6th race on November 23, 2024, at Zia Park while aboard # 6 "Eyoftocard" who veered out sharply into #'s 7 & 8 practically causing the #8 horse to unseat its rider and costing an opportunity for a better placing. #6 "Eyoftocard" was disqualified from 3rd to 8th place.

For this violation, the Board of Stewards issued the following penalty:  
A 7-calendar day suspension, beginning on December 2, 2024, through *December 8, 2024*.  
Mr. Jacob Enriquez may ride designated races.

Licensee is found in violation of:  
15.2.5.13(E)(2)(a) NMAC: Post to Finish Which states in pertinent part that "A jockey shall not ride carelessly or willfully so as to permit his/her mount to interfere with, impede or intimidate any other horse in the race."  
15.2.5.13(E)(3)(a) NMAC: Which states in pertinent part that "When the way is clear in a race, a horse may be ridden to any part of the course, but if any horse swerves, or is ridden to either side, so as to interfere with, impede, or intimidate any other horse, it is a foul."  
15.2.5.13 (E)(3)(b) The offending horse may be disqualified, if in the opinion of the stewards, the foul altered the finish of the race, regardless of whether the foul was accidental, willful or the result of careless riding.  
15.2.5.13 (E)(4)(a) Disqualification: When the stewards determine that a horse shall be disqualified for interference, they may place the offending horse behind such horse as in their judgment it interfered with, or they may place it last.

This ruling is written in accordance with:

15.2.1.9(b): Which states in pertinent part that "An appeal under this section must be filed not later than 10 days after the date of the ruling.
