The Board of Stewards hereby issue the following penalty:

A fine of Five Hundred Dollars (\$500.00) which must be paid on or before December 22, 2024. In accordance with NMAC 15.2.3.8 (B)(3)(e)(i). Failure to pay the fine within the prescribed time may result in immediate suspension. Pursuant to Rule NMAC 15.2.1.9 A(7) (f) all fines imposed by the stewards shall be paid to the commission within 14 days after the ruling is issued, unless otherwise ordered.

The horse Lika Dagger will be put on the stewards list for Seven (7) days starting December 9. 2024 thru December 15, 2024.

Trainer: Daniel Cano having been duly notified appeared telephonically before The ZIA Park Board of Stewards on December 9, 2024, and waived his 10 day notice and disciplinary hearing, regarding a lab report from Industrial Laboratories (The official testing laboratory for the NMRC), for a confirmed positive for the drug, Flunixin (class 4 C penalty drug) found in test sample E547716 taken from the 1st place finisher "Juniors Legacy" following the 6th race, on November 16, 2024 at Zia Park.

The original lab report indicated a finding of Flunixin at 46.2 ug/ml +/-0.04 ug/ml in the blood, the allowable limit for Flunixin is 5 ng/ml in the blood for a 4-C violation (15.2.6.9 Attachment 2).

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the trainer, and declined by trainer.

Daniel Cano is the Trainer of record for horse "Juniors Legacy" at the time of the violation.

This is Daniel Cano's first 4C-Major medication violation, in a 365-day period, issued in accordance with 15.2.6.9 (B)(4). The Board of Stewards assessed a penalty as follows:

Aggravating circumstances:

1. The allowable limit for Flunixin is 5 ng/ml, the horse "Juniors Legacy" tested positive at a level of 46.2 ng/m Threshold of 5ng/ml.

Mitigating circumstances:

This is trainer Daniel Cano's first violation of this classification in 365 days.

For this violation Daniel Cano's is fined \$1000.00 (One Thousand dollars). The fine is to be paid on or before December 23, 2024, in accordance with 15.2.3.8 (B) (3) (1). Failure to pay the fine within the time prescribed shall result in immediate suspension.

In addition, Daniel Cano has accumulated "0" points prior to this ruling and "0.5" points in connection with this ruling for a current total of "0.5" under the multiple medication violation point system.

Owner Ramona Delgado having appeared telephonically and been duly notified and waving her 10 day notice and disciplinary hearing before the ZIA Park Board of Stewards on December 9, 2024 regarding a medication violation on November 16, 2024, Zia Park Racetrack, involving the first-place finisher of the 6th race, "Juniors Legacy", for Flunixin, a Class 4 Penalty C drug, found in blood sample #E547716, confirmed by Industrial Laboratories (the official lab for the NMRC). at 46.2ng/mL. The measurement uncertainty of the method is 0.58 ng/ml at the threshold of 5 ng/mL.

Owner Ramona Delgado was offered a split sample and declined Mr. Daniel Cano was the trainer of record for "Juniors Legacy". In accordance with Rule 15.2.6.9(B)(4) PENALTY RECOMMENDATIONS, This is Owner Ramona Delgado's first Class 4C medication violation in a 365-day period. The ZIA Park Board of Stewards hereby issue the following penalty:

The purse redistribution is as follows:

Trainer/Owner Sean Alfortish is hereby summarily suspended, effective December 10, 2024, pending the outcome of his summary suspension hearing scheduled for December 17, 2024, at 8:30 A.M. in the office of the Board of Stewards at Zia Park Race Track (3901 West Millen Drive Hobbs, NM 88240), per Rule 15.2.1.9 (A)(3)(a) (Summary Suspension). The summary suspension is regarding the fact that the Zia Park Board of Stewards has learned licensee Sean Alfortish has been federally indicted by a grand jury in connection with a wide-ranging investigation regarding a conspiracy to stage automobile accidents in order to benefit from financial settlements with the insurance companies of the other vehicles involved in the staged accidents. Mr. Alfortish was charged with one (1) count of conspiracy to commit mail and wire fraud, three (3) counts of obstruction of justice, and four (4) counts of witness tampering.

NMSA 1978, Section 60-1A-5(B) of the statutory Horse Racing Act, provides "Every license issued by the commission shall require the licensee to comply with the rules adopted by the commission."

NMSA 1978, Section 60-1A-11(A) of the Horse Racing Act reads in part:

- "A. A license shall not be issued or renewed unless the applicant has satisfied the commission that the applicant:
 - (1) is of good moral character, is honest and has integrity:
 - does not currently have a license suspended by a horse racing licensing authority (2) in another jurisdiction;
 - does not have any prior activities, criminal record, reputation, habits or associations that:
 - (a) pose a threat to the public interest;
 - (b) pose a threat to the effective regulation and control of horse racing, or
 - (c) create or enhance the dangers of unsuitable, unfair or illegal practices, methods and activities in the conduct of horse racing, the business of operating a horse racetrack licensed pursuant to the Horse Racing Act or the financial activities incidental to operating a horse racetrack;
 - is qualified to be licensed consistent with the Horse Racing Act...". (4)

NMRC Rule 15.2.1.9(A)(3)(a) provides

"(3) Summary suspension.

If the stewards determine that a licensee's actions constitute an immediate danger to .1 the public health, safety, integrity or welfare of the horseracing industry, the stewards

NMAC 16.47.1.8 (L)(1)(i) "Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license: (1) The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant:

(i) is a person whose conduct or reputation may adversely reflect on the honesty and integrity of horse racing or interfere with the orderly conduct of a race meeting; interfering with the orderly conduct of a race meeting shall include, but is not limited to, disruptive or intemperate behavior or behavior which exposes others to danger anywhere on the racetrack grounds; the fact that the race meet was not actually interrupted is not a defense to the imposition of discipline under this rule...."

The Board of Stewards recognizes that under our criminal justice system in this country, every person is presumed innocent until and unless they are found guilty. However, an administrative license issued by the Commission to participate in horse racing in New Mexico is a privilege, not a right. Additionally, the Board of Stewards and Commission operate and regulate under both statutes and administrative rules specific to the civil administrative laws governing the state's horse racing industry. Civil administrative matters have different standards of review and burdens or proof, as compared to the beyond a reasonable doubt standard for criminal convictions. Mr. Alfortish, who was an attorney until he was disbarred based on a prior criminal conviction, was indicted by a grand jury of fellow citizens in his state for several serious federal law criminal violations. The grand jury determined it heard evidence sufficient to warrant an indictment such that the federal government could prosecute him in criminal court and if successful have a jury convict Mr. Alfortish of federal crime(s).

.In accordance with Rule 15.2.1.9 (B)(21)(a)(b), Sean Alfortish is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Sean Alfortish are ineligible to be entered or start in any race in this jurisdiction, per Rule 15.2.1.9(B)(21)(c). NMSA 1978, Section 60-1A-4(A) provides "The commission may exclude or compel the exclusion of a person from all horse racetracks who the commission deems detrimental to the best interests of horse racing..."

Trainer, Osman Iturralde, is hereby summarily suspended, effective immediately, December 18, 2024, pending the outcome of his summary suspension hearing scheduled for Monday, December 23rd, 2024, at 9:00 A.M. in the office of the Board of Stewards at Sunland Park (1200 Futurity Drive, Sunland Park NM 88063), per 15.2.1.9 (B)(3)(b) Summary Suspension. The summary suspension is regarding a medication violation on November 30th, 2024, for first place finisher "Kings Money Moon" from the 3rd race at Zia Park. Sample E547770 tested positive for the drug Albuterol a class 3 penalty A drug. An affidavit from Industrial Laboratories (the official laboratory for the NMAC.) on December 5th, 2024, reported the presence of Albuterol confirmed in urine.

(Osman Iturralde, was listed as the Trainer of "Kings Money Moon" at the time of this race.)
