Jockey, Sergio Becerra, having been properly summoned and having appeared before the Sunland Park Board of Stewards, on January 12, 2025, for careless riding during the running of the 5th race on January 11, 2025, while aboard # 4 "Harken", who bore in sharply into the path of #3 causing interference and a disqualification of his mount from first to 5th place.

For this violation, the Board of Stewards issued the following penalty:

A 7-calendar day suspension, beginning on January 20, 2025, through January 26, 2025.

Mr. Sergio Becerra may ride designated races.

Trainer Andres Gonzalez having been duly notified and having appeared before the Sunland Park Board of Stewards on January 12, 2025, waived his right to a 10-day notice and formal hearing for failure to have a flipping halter on his entry "Bigg Deal" for the 9th race on January 11, 2025, necessitating a late scratch and pari-mutuel refunds.

The Board of Stewards hereby issue the following penalty:

1.A fine of Five Hundred Dollars (\$500.00) which must be paid on or before January 25, 2025, In accordance with NMAC 15.2.3.8 (B)(3)(e)(i). Failure to pay the fine within the prescribed time may result in immediate suspension. Jockey Daniel Torres opted to waive his summary suspension hearing, 10-day notice, and disciplinary hearing before the board of Stewards at Sunland Park Racetrack at 10:00 a.m. on January 12, 2025, having tested positive for a prohibited substance (Marijuana) in a UA sample given by investigator Elizabeth Garcia while on the grounds at Sunland Park.

The Board of Stewards determined mitigating/Aggravating factors:

- First Offense
- Admitting guilt

The Board of Stewards hereby assesses a penalty as follows:

1. A 15-day (Fifteen) suspension beginning January 12, 2025, through January 27, 2025. In accordance with 15.2.1.9 (C)(21), Jockey Daniel Torres is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Before being reinstated must pass a drug test on or after February 27, 2025.

Licensee is found in violation and this ruling is written in accordance with:

- First Offense
- Admitting guilt

The Board of Stewards hereby assesses a penalty as follows:

- 1. 1. A 15-day (Fifteen) suspension beginning January 12, 2025, through January 26, 2025. In accordance with 15.2.1.9 (B)(21), Jockey Christian Cardenas is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Pursuant to Commission Rule 16.47.1.12(G)(2), during that period of suspension Mr. Cardenas may not exercise horses or run in designated races; and
- 2. Before being reinstated, Mr. Cardenas must take and pass a drug test on or after January 27, 2025, that test to be given under the supervision of the New Mexico Racing Commission.
