Trainer, Alfredo Gomez, having been duly notified and having failed to appear for his Summary Suspension hearing, which was held in absentia, on January 16, 2025 at 8:35 a.m. before the Sunland Park Board of Stewards regarding a medication violation on December 15th, 2024, for first place finisher "La Nanas" from the 3rd race at Zia Park, Sample E547836 tested positive for the drug Albuterol a class 3 penalty A drug. An affidavit from Industrial Laboratories (the official laboratory for the NMAC.) on January 7th, 2025, reported the presence of Albuterol confirmed in urine.

After hearing testimony and evidence presented the Board of Stewards determined that Mr. Alfredo Gomez shall remain summarily suspended pending the outcome of his disciplinary hearing.

Alfredo Gomez was listed as the Trainer of "La Nanas" at the time of this race. Trainer Alfredo Gomez was afforded a split sample and declined. (Pursuant to NMRC 15.2.6.10.(D)(2))

NMAC 16.47.1.8 (L)(1)(i) Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license: (1) The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant:

(i) is a person whose conduct or reputation may adversely reflect on the honesty and integrity of horse racing or interfere with the orderly conduct of a race meeting; interfering with the orderly conduct of a race meeting shall include, but is not limited to, disruptive or intemperate behavior or behavior which exposes others to danger anywhere on the racetrack grounds; the fact that the race meet was not actually interrupted is not a defense to the imposition of discipline under this rule;

In accordance with 15.2.1.9 (B)(21), Alfredo Gomez is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Alfredo Gomez are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (B)(21)(c). All transfers and sales of horses trained, owned, or in the care and custody of Alfredo Gomez must be done in accordance with 15.2.6.9(A)(13)(a)(b)(c) Medication and Prohibited Substances, 16.47.1.10 (D)(5) Trainers And 15.2.1.9(A)(1)(4)(b)(c)(d) Due Process and Disciplinary Action..
