Trainer Francisco M. Gonzalez, having been duly notified for his disciplinary hearing and having responded by telephone, waived his right to a formal hearing before the Sunland Park Board of Stewards at 9:00 a.m. on February 12, 2025, regarding a confirmed positive test for Albuterol, a Class 3, Penalty A drug, by Industrial Laboratory, the official laboratory of the NMRC, for sample #E547826 (Urine) on the horse "Ms Sandy P" who finished 1st in the 5th race, a QH Maiden Race, on December 14, 2024, at Zia Park Racetrack in Hobbs New Mexico.

Split sample testing rights were afforded to and declined by trainer Mr. Francisco M. Gonzalez. Pursuant to Rule 15.2.6.10(D)(2).

This hearing involves the following Commission Rules, whether Mr. Francisco M. Gonzalez has violated any such Rules and, if so, whether a penalty or other disciplinary action should be imposed upon him as a result:

For this violation (First lifetime violation), the following penalties are imposed:

- 1. Mr. Francisco M. Gonzalez is hereby fined \$10,000.00 (Ten-Thousand Dollars). The fine is to be paid on or before February 26, 2025, in accordance with Rule 15.2.1.9(A)(7)(f). Failure to pay the fine in the prescribed time shall result in an immediate suspension.
- 2. Mr. Francisco M. Gonzalez shall have his trainer's license suspended for a period of one (1) year. The term of suspension shall start retroactive from the date of her Summary Suspension, January 8, 2024, and run through January 8, 2026.
- 3. Ms. Francisco M. Gonzalez has accumulated "0" points prior to this infraction and "6" points in connection with this Ruling for a current total of "6" points under the multiple medication violation point system. Therefore, Mr. Francisco M. Gonzalez shall receive an additional thirty (30) days to his

period of suspension, beginning January 9, 2026 through February 8, 2026.

4. In order to be restored to good standing, Mr. Francisco M. Gonzalez shall be required to take and pass all sections of the New Mexico Racing Commission written Trainers Test. Failure to pass all sections in accordance with Rule 16.47.1.10(A)(1-9) will result in the revocation of her license.

In accordance with Rule 15.2.1.9(B)(21), Mr. Francisco M. Gonzalez will be excluded from all areas and grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Mr. Francisco. Gonzalez are ineligible to be entered or start in any race in this jurisdiction, per Rule 15.2.1.9(B)(21)(c). All transfers and sales of horses trained, owned, or in the care and custody of Mr. Francisco M. Gonzalez must be done in accordance with Rule 15.2.6.9(A)(13)(a)(b).
