In reference to the ruling from the Texas Racing Commission Ruling LSP 32350 and in accordance with 16.47.1.8 (L)(1)(e) Reciprocity, the Owner/Trainer licenses issued to Toby Keeton (NMRC Applicant ID #11966) are hereby suspended until such time the ruling has been cleared and is in good standing with the Texas Racing Commission. During said time of applicable suspension, Toby Keeton is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC, in accordance with 15.2.1.9 (B)(21) Exclusion. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of, Toby Keeton are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (B)(21)(c) Exclusion.

Persons subject to rulings in other jurisdictions shall have the right to request a hearing before the commission to show cause why such ruling should not be enforced in this jurisdiction. Any request for such hearing must clearly set forth in writing the reasons for the appeal.

If the deadline falls on a Saturday, Sunday or legal holiday, the period is extended to include the next day that is not a Saturday, Sunday or legal holiday. The appeal must be received by noon, at the main commission offices or with the stewards who issued the ruling and must be accompanied by a fee in the amount of \$400. The fee must be in the form of cash, a cashier's check, money order or personal check." The last day to file an appeal is February 11, 2025
