Ruling:

Jockey Jesse Levario having been duly notified and having appeared before the Sunland Park Board of Stewards on February 2, 2025, for excessive use of whip, while aboard #3 "Honey Lynn Perry" in the 6th Race February 1, 2025, at Sunland Park.

For this violation, the Board of Stewards issued the following:

Jesse Levario (1st offense) a fine in the amount of Five Hundred Dollars. (\$500.00). This fine is to be paid on or before February 16, 2025, in accordance with NMAC 15.2.1.9 (A)(7)(f). Failure to pay the fine in the prescribed time shall result in an immediate suspension.

Licensee is found to be in violation of NMAC:

15.2.5.13(E)(7)(a) Use of riding crops. Although the use of a riding crop is not required, any jockey who uses a riding crop during a race shall do so only in a manner consistent with exerting his or her best efforts to win.

15.2.5.13(E)(9)(a)(b) Excessive use of the crop;

(a) Riders cannot use the riding crop more than three times in succession during a race, excluding showing or waiving the crop. (b) Riders cannot use the crop more than three times in succession without giving the horse a chance to respond before using the crop again.

Ruling:

Jockey, Alejandro Medellin, having been properly summoned and having appeared before the Sunland Park Board of Stewards, on February 1, 2025, for careless riding during the running of the 7th race on January 31, 2025, while aboard #6 "Deck Humor" who drifted out into the path of #9.

For this violation, the Board of Stewards issued the following penalty:

A 7-calendar day suspension, beginning on February 9, 2025, through February 15, 2025.

Mr. Alejandro Medellin may ride designated races.

Licensee is found in violation of NMAC:

15.2.5.13(E)(2)(a) Post to Finish: Which states in pertinent part that "A jockey shall not ride carelessly or willfully so as to permit his/her mount to interfere with, impede or intimidate any other horse in the race."

15.2.5.13(E)(3)(a) Which states in pertinent part that "When the way is clear in a race, a horse may be ridden to any part of the course, but if any horse swerves, or is ridden to either side, so as to interfere with, impede, or intimidate any other horse, it is a foul."
