Trainer Jose Ignacio De Herrera, having been duly notified and having waived his right to a 10-day notice and formal hearing regarding a confirmed positive test for the drug Phenylbutazone at 9.45 ug/mL, with a threshold 0.3 mcg/ml a Class 4, Penalty C drug, by Industrial Laboratory, the official laboratory of the NMRC, for sample #E547953 at 9.45 ug/mL (blood) on the horse "Prince Drue Drue" who finished 1st in the 4th race, (QH Maiden Claiming) on February 1st, 2025, at Sunland Park Racetrack in Sunland Park, New Mexico.

Trainer Jose Ignacio De Herrera was afforded a split sample and declined.

Aggravating factors:

Extremely Exceeding permissible level

For this violation (first offense 365-day period) the Board of Stewards issues the following penalties:

1. A fine of Three Thousand Five -Hundred Dollars (\$3,500.00) which must be paid on or before March 9, 2025, in accordance with NMAC 15.2.3.8 (B)(3)(e). Failure to pay the fine within the prescribed time may result in immediate suspension. Pursuant to NMAC 15.2.1.9(A)(7)(f) all fines imposed by the Stewards shall be paid to the Commission within 14 days after the Ruling is issued, unless otherwise ordered.

Chavez having been duly notified and having been represented by trainer Jose Ignacio De Herrera, waived his right to a 10-day notice and formal hearing, Regarding a confirmed positive test for sample E547953 on horse "Prince Drue Drue" for a Phenylbutazone positive confirmed in the blood at 9.45ug/mL, who finished 1st in the 4th race, QH Maiden Claiming Race on February 1, 2025 at Sunland Park, a Class 4, Penalty C.

Split sample testing rights were afforded to the owner Mr. Javier M. Chavez and was declined.

Mr. Jose DeHerrera was the trainer of record on February 1, 2025, for "Prince Drue".

Given the evidence presented, Mr. Javier M. Chavez is found to be in violation of the following **Commission Rules:**
